# I. UN System under the Charter & Self-determination

- Art. 73(a) protection of culture, political, economic, social & educational advancement, just treatment
- Art. 73(b)- develop self-government (referendum, etc.)
- [Art. 73(c)]
- Art. 73 (d)- promote constructive measures of development
- Art. 73 (e)- transmit to Secretary General information on economic, social, and educational conditions in the territories.

#### Mechanisms under the Charter Based System

- Human Rights Council
- Special Procedures- includes Special Rapporteurs, Independent Experts and Working Groups with 46 Thematic Mandates & 14 Country Mandates
- Universal Periodic Review
- Independent Investigations
- [Regional Systems, included in Ch. VIII of UN Charter, i.e., European Union, Interamerican, African, ASEAN]

**UN Charter, Chapter XI, Art. 73-Non-Self-Governing Territories** 

> Mentions a list of responsibilities directed to Members of the United Nations, which have or assume responsibilities (or "sacred trusts") in the administration of territories whose peoples have not yet attained a full measure of self-government.

#### Puerto Rico's Case under the Charter

-Background (1898- )- military & civil government -Political situation and plenary powers of the US government

-alleged self-government with the Commonwealth/ELA, voted in 1952 & in 1953 the US informed the UN that it had no duty to inform;
-Resolution 748(XVIII)

-PROMESA statute imposed by the US to deal with insolvency

### General Assembly Resolutions on Self-Determination

- Special Committee to determine if obligation existed under Art. 73(e) of the UN Charter
- 1541(XV) of 1960 [guidelines, explained later]
- 1514 (XV) of 1960 [Magna Carta of Decolonization]

# Other arrangements by the UN for self-determination

- Participation in country referendum
- Negotiated solutions (2 Administrative Powers)
- Trusteeship Council as observer in plebiscites
- Receipt of writen petitions
- Hearings of petitioners (art. 87b of the Trusteeship Council)

- Political status alternatives in colonial situations: Puerto Rico's annexation is not an option
